Recently, Goncalves told she took out the trash to the dumpster located across the parking lot and felt there was a figure standing around close by. Goncalves texted her friend, and asked her when she would be home. Goncalves was home alone at the time.
22. Sgt. Hoxie asked if she heard about how the girl's day had gone. She heard about the days activities from and through Snap Chat. said they had a really good day and had fun. It sounded like they started at their house and went to the said Apartments. She believed at some point, Kernodle and her boyfriend, and went back to the house, because they weren't twenty-one years old. Mogen and Goncalves then went to the Corner Club.
