2. She's part of the [REDACTED] sorority at the University of Idaho. She knew Ethan CHAPIN through his [REDACTED] fraternity. She got to know Xana KERNODLE through CHAPIN. She didn't know Kaylee GONCALVES or Madison MOGEN very well. She knew CHAPIN and KERNODLE for 1 1/2 years.
3. She currently lives at the sorority house and had never been to the 1122 King Rd house.
4. She was at the [REDACTED] fraternity house on Saturday night (November 12th) for a party. CHAPIN and KERNODLE were at the party.
5. She had never heard of any sort of stalking incidents.
6. She was with KERNODLE until 2:00 AM. She took a picture with KERNODLE and walked home. CHAPIN and KERNODLE remained at the party. She had no further contact with them.
7. KERNODLE had been dating CHAPIN for about a year. Everyone had a crush on KERNODLE.
8. She heard [REDACTED] was at the 1122 King Rd house after the [REDACTED] party. [REDACTED] is a [REDACTED] and a PC brother of CHAPIN.
