- 6. He walked back to the house at approximately 6:30-7:00 P.M.
- 7. At approximately 12:30 A.M., he went to the fraternity. He left there around 4:15 A.M.
- 8. He was back at the house and fell asleep around 5:00 A.M.
- 9. Of the victims he knew Xana and Ethan.
- 10. He had been to Xana's apartment more times than he could recall over the last year or 2.
- 11. He was at Xana's apartment the weekend before the homicides.
- 12. The last time he saw Xana and her roommates was at the (specifically apartment) around 3:00-5:00 P.M.
