### Summary Narrative

On November 13, 2022, at about 12:22 p.m., the Moscow Police Department (MPD) requested Idaho State Police (ISP) District 2 (D2) Investigations to assist with multiple homicides at 1122 King Rd., Moscow, Latah County, Idaho. The victims were identified as Kaylee Goncalves (GONCALVES), Madison Mogen (MOGEN), Xana Kernodle (KERNODLE), and Ethan Chapin (CHAPIN).

I, ISP Detective (Det.) Jeffory R. Talbott was assigned as the lead crime scene investigator. On November 19 and 20, 2022, ISP personnel returned to the scene for further processing and evidence collection. All items collected were turned over to MPD.

**Narrative**

- On November 19, 2022, at about 2:03 p.m., I returned to 1122 King Rd., Moscow, Latah County, Idaho for further processing.
- At about 5:24 p.m., I resealed the front door and left the scene. MPD remained on the scene outside the residence.
- On November 20, 2022, at about 8:16 a.m., I returned to 1122 King Rd. At about 8:58 a.m., ISP Det. Hugh Powell and ISP Trooper (Tpr.) Kristen Noah arrived at the scene to assist.
- I marked the evidence with numbered placards while Det. Powell and I photographed the exhibits. The following evidence was recorded and/or collected:
  - Exhibit 075 - Power cord, located on floor next to east wall of floor 1, west bedroom.
  - Exhibit 076 - Power cord, located on upper shelf of closet of floor 3, west bedroom.
  - Exhibit 077 - Black-colored iPhone, located in drawer in closet of floor 3, west bedroom.
  - Exhibit 078 - SD card, located inside a Go-Pro in a drawer in closet of floor 3, west bedroom.
  - Exhibit 079 - Handwritten note, located inside clear plastic tote of upper shelf in closet of floor 2, east bedroom.
  - Exhibit 080 - Diary, located on desk of floor 2, east bedroom.
  - Exhibit 081 - iPhone, located in glove box of the blue-colored Honda Civic.
- At about 11:58 a.m., Det. Powell and Tpr. Noah left the scene.
- At about 12:05 p.m., I resealed the front door and left the scene. MPD remained on the scene outside the residence.
- I transported the items collected to the MPD and turned the items over to MPD evidence technician Tim Smalldrige.
- I entered the scene photographs into evidence, located at the ISP District 2 office, and provided copies to the MPD.
