Summary Narrative

On Sunday, December 4, 2022, I, Idaho State Police (ISP) Senior Detective Gary Tolleson received a telephone call from Coeur d'Alene Police Department Sergeant Shane Averitt. Sergeant Averitt advised me of the arrest of an [REDACTED] (DOB [REDACTED]/2001) for being drunk in public. During the arrest, [REDACTED] claimed to have stabbed two people in New Jersey as well as being involved in the homicides in Moscow, Idaho.

Narrative

1. On Sunday, December 4, 2022, I, Idaho State Police (ISP) Senior Detective Gary Tolleson received a telephone call from Coeur d'Alene Police Department (CDA PD) Sergeant Shane Averitt. Sergeant Averitt advised me that CDA PD officers had arrested [REDACTED] (DOB [REDACTED] 2001) for being drunk in public (CDA PD case number [REDACTED]). During the arrest, [REDACTED] claimed to have stabbed two people in New Jersey and told officers he was also involved in the murders in Moscow, Idaho. He later recanted these statements to the officers.

2. Sergeant Averitt also explained that CDA PD officers have had contacts with [REDACTED] over the last few months because they had found him living in his red van.

3. I went to Regional Communications Center North (RCCN) and asked ISP Senior Dispatcher Mary Conrad to print a copy of the CDA PD report ([REDACTED]) from the SPILLMAN computer program. After reading the report, I asked Conrad to run [REDACTED]. She found an old warrant hit out of Chatham Township, New Jersey (Case Number [REDACTED]).

4. We then checked the BOSS camera system for the dates of November 12 - 13, 2022, looking for [REDACTED]

vehicle, license plate [REDACTED] (New Jersey). The vehicle is seen on camera driving in Coeur d'Alene on several days prior to the murders and after.

5. I telephoned Chatham Township Police Department in New Jersey and spoke to officer Nick Giordano. He told me he was familiar with [REDACTED] and had taken several reports on him. Giordano said his agency had 61 reports on [REDACTED]. He described [REDACTED] as wanting to be a Rapper and/or a Tic-Toc Star. In addition, they had no reports of a stabbing or murders in their Township. Officer Giordano described the Township as a small affluent community.

6. I asked Officer Giordano for a law enforcement contact with the local county sheriff office. Giordano told me that the Chatham Township is in Morris County, New Jersey. I telephoned the sheriff office and requested an agency contact. I received a telephone call from Detective Tim Palazzolo [REDACTED]. Detective Palazzolo told me he is with the county fugitive unit. He reiterated that his computer check showed 61 reports on [REDACTED]. The last contact with [REDACTED] in the county was on September 7, 2022.

7. Several minutes later I received a telephone call from Detective Matt Magnone of the Major Crime Division [REDACTED] of the New Jersey State Police. He also told me that there were no unsolved murders in the county.

8. I drove to the Kootenai County Jail and spoke to [REDACTED]. [REDACTED] told me he did not remember ever saying that he stabbed anyone. He signed a consent form and let me take a DNA sample using a buccal swab kit. I then had him lift his short sleeve shirt to look at his arms and neck. No marks or scratches were visible.

9. During our conversation [REDACTED] told me he had never been to Moscow Idaho, that he had only been in Idaho a couple of months. He also told me he would say "stupid shit" when he had been drinking.

10. The conversation with [REDACTED] was recorded with his knowledge and permission. I later transferred the recording to a compact disc.

11. I took the Buccal swabs I obtained from [REDACTED] and the interview recording CD to the Moscow Police Department and placed them into evidence.

CASE SUMMARY:

On 12/03/22 at 2122 hours, [REDACTED] was arrested for being heavily intoxicated in the roadway of the 1400 block of E St Maries Avenue. [REDACTED] was staggering side to side in the middle of the road and caused several vehicles to alter their driving patterns in order to avoid a collision. [REDACTED] booked into PSB.

NARRATIVE:

On 12/03/22 at 2044 hours, Officer Cowan K45 and I responded to 1410 E St Maries Avenue to investigate a suspicious circumstance. The reporting party, [REDACTED] called police because [REDACTED] was intoxicated and admitted he had killed several people included those in Moscow.

Upon arrival, [REDACTED] was contacted and identified by his New Jersey identification card. [REDACTED] vehicle was documented as well. The vehicle was a red [REDACTED] bearing New Jersey license plate [REDACTED] there was nothing suspicious in plain view inside the vehicle. [REDACTED] attempted to recant his comments about murdering several people.

While speaking to [REDACTED] he was staggering side to side and swaying in a circular pattern while slurring his words. [REDACTED] requested [REDACTED] be trespassed from the property. [REDACTED] was given his trespass admonishment and, in an attempt to allow him to leave the scene without criminal intervention, Officer Cowan requested a cab in order to transport [REDACTED] to his desired location.

As [REDACTED] was no longer on [REDACTED] property, Officer Cowan and I cleared the scene. Based on [REDACTED] general demeanor, Officer Cowan and I expected a return call to the location. Officer Cowan and I stayed in the area.

At 2118 hours, [REDACTED] called 911. As Officer Cowan and I were driving back to the location I spoke to the cab driver who we requested on [REDACTED] behalf. The cab driver essentially told me [REDACTED] refused to enter the cab.

As I was approaching the location, I saw [REDACTED] in the middle of the street staggering side to side while two vehicles were traveling westbound past him from 15th street which is a main thoroughfare. Based on the totality of the events, [REDACTED] was arrested for the above listed charge. At KCPSB [REDACTED] failed booking due to his disruptive and boisterous behavior.
