7. also told Detectives about an instance where Kaylee Goncalves was followed by a male while she was at Winco. She explained the male followed her in the store and out to her car. did not know any other specifics about the encounter.
8. explained the deceased and and and were pretty good about the security at the house and did not just give out the door code.

When asked if she could think of anybody who would want to this, told Detectives about her physics lab , unknown phone number). said when she emailed him about missing class, he mentioned to her thought maybe he would have seen or heard something. described Haw as red-eyed, always tired and stressed out but was a good
