Narrative

1. On December 1, 2022, at approximately 1805 hours, Idaho State Police Detectives Matthew Heinle and Cody Herman conducted a phone interview with [REDACTED] [REDACTED] (DOB: [REDACTED]/2002) at [REDACTED] at the Moscow Police Department and recorded the phone call. Recording #D-7 was submitted into evidence at the Moscow Police Department. See recording for full details.
2. [REDACTED] told Detectives she was a [REDACTED] and lived at the [REDACTED] sorority house. [REDACTED] stated she knew [REDACTED] from being in the same rush group and met [REDACTED] through [REDACTED] and [REDACTED], who were mutual friends. [REDACTED] said she had known [REDACTED] and [REDACTED] since about August of 2021.
3. [REDACTED] to Detectives her activities during the day of November 12 and the early morning of November 13, 2022, as follows:
- a. Went to [REDACTED] [REDACTED] or [REDACTED] for a BBQ around 1:00 p.m. with [REDACTED] [REDACTED] [REDACTED] (unknown spelling of last name), [REDACTED] (unknown phone number), [REDACTED] (unknown phone number), and [REDACTED] [REDACTED] (brother, unknown phone number).
 - b. Went to the Vandal game around 3:00 or 4:00 p.m. with [REDACTED] [REDACTED] [REDACTED], [REDACTED] [REDACTED] (unknown phone number), and [REDACTED] [REDACTED] (unknown phone number).
 - c. Stayed at the game until about half-time, then went back to [REDACTED] and was there until around 8:30 p.m.
 - d. Went to [REDACTED] with [REDACTED] [REDACTED] and [REDACTED] [REDACTED] (unknown phone number) so she could change to go to [REDACTED] 21st birthday party at a [REDACTED] and [REDACTED] out-of-house residence on [REDACTED] (unknown house number).
 - e. Left around 11:30 p.m. with [REDACTED] and went to the [REDACTED] house.
 - f. While at the [REDACTED], [REDACTED] and [REDACTED] hung out with [REDACTED], Xana Kernodle, and Ethan Chapin in [REDACTED].
 - g. [REDACTED] hung out for a couple hours at the [REDACTED] house and ran into [REDACTED] at around 12:00 or 12:30 a.m. [REDACTED] told [REDACTED] she couldn't get drunk and made a statement to the effect of, "She wasn't feeling it." [REDACTED] stated at one point, [REDACTED] told her she wanted to go the [REDACTED] [REDACTED] house ([REDACTED], Moscow Idaho, [REDACTED]), but [REDACTED] was not ready to leave yet.

- h. [REDACTED] left the [REDACTED] house and went to the [REDACTED] lodge and hung out for a while.
- i. [REDACTED] and [REDACTED] left [REDACTED] around 1:15 or 1:30 a.m. and went to [REDACTED] house. [REDACTED] did not go with [REDACTED] to [REDACTED] house.
- j. At [REDACTED] house was [REDACTED], [REDACTED], [REDACTED] (unknown phone number), [REDACTED] (unknown phone number), and [REDACTED] (unknown phone number), [REDACTED] roommate, unknown phone number).
- k. [REDACTED] said [REDACTED] only stayed for approximately 10 minutes then walked home.
- l. [REDACTED] left [REDACTED] house at around 3:30 a.m. with [REDACTED] and [REDACTED] and went to [REDACTED] to drop [REDACTED] off and [REDACTED] and [REDACTED] went to [REDACTED] so [REDACTED] could eat.
- m. After [REDACTED] ate, [REDACTED] and [REDACTED] went to [REDACTED] house [REDACTED] and stayed the night there.
4. [REDACTED] described her activities on the day of November 13, 2022, after waking up as follows:
- a. [REDACTED] woke up around 10:00 or 11:00 a.m., went home, showered, grabbed food/coffee, and went back to [REDACTED]
- b. [REDACTED] found out about the murders from [REDACTED]
- c. At around 7:00 or 7:30 p.m. [REDACTED], [REDACTED], and [REDACTED] went to the [REDACTED] hotel where [REDACTED] and [REDACTED] were staying.
- d. [REDACTED] left the hotel at around 9:30 p.m. with [REDACTED], [REDACTED], and [REDACTED].
5. [REDACTED] told Detectives while she was at the hotel, [REDACTED] told them she saw someone in the house wearing a ski mask and had made eye contact with them but didn't know what was going on because she was out of it. This struck [REDACTED] as odd because she remembered [REDACTED] saying she wasn't getting drunk that night.
6. [REDACTED] also said in a previous point in the interview that shortly after [REDACTED] moved into the house, she had made comments about not feeling safe at the house because of where her room was in relation to the door, and she felt she was being watched. [REDACTED] did not know anything further about that specifically.
7. [REDACTED] also told Detectives about an instance where Kaylee Goncalves was followed by a male while she was at Winco. She explained the male followed her in the store and out to her car. [REDACTED] did not know any other specifics about the encounter.
8. [REDACTED] explained the deceased and [REDACTED] and [REDACTED] were pretty good about the security at the house and did not just give out the door code.
9. When asked if she could think of anybody who would want to this, [REDACTED] told Detectives about her physics lab [REDACTED] (unknown phone number). [REDACTED] said when she emailed him about missing class, he mentioned to her [REDACTED] on King Street and [REDACTED] thought maybe he would have seen or heard something. [REDACTED] described Haw as red-eyed, always tired and stressed out but was a good [REDACTED]
