2. stated she was friends with Xana Kernodle for two and a half years and more recently with Ethan Chapin since he began dating Kernodle. stated Kernodle would have a gathering every weekend or every other weekend and she would regularly attend. stated she knew who the other people at the house or the people who would usually attend the gatherings.
3. stated on November 3, 2022, she had gone over to Kernodle's apartment located at 1122 King Rd in Moscow, Idaho around 1 p.m. and was there for about 15 minutes. stated everyone then left and went over to another apartment commonly referred to as the, for a pre-game party. stated her friends and Kernodle then went to another friend's house named and her friends then attended the football game and Kernodle decided not to go. Following the game, called Kernodle at approximately 7 p.m. Kernodle stated she and her roommates were at their apartment taking a nap and would decide later if they were going to go back out.
4. stated when Kernodle would have get togethers she would usually invite men from the 'stated and stated her friend group would also be invited. stated it was usually the same people from each house that would come.
5. stated she knew Kernodle occasionally stated she wasn't usually around when she would
6. stated she had heard rumors of Kaylee having a stalker, but only had heard about it after the murders. said the back door was always kept unlocked because the front door had a code and would usually lock automatically. stated she heard of other rumors that one of the roommates had taken the dog out and someone jumped out of a tree at them. said she heard another rumor that the killer entered the back door and was wearing a mask.
7. stated after the football game she went home and eventually fell asleep.
