2. [REDACTED] stated she was friends with Xana Kernodle for two and a half years and more recently with Ethan Chapin since he began dating Kernodle. [REDACTED] stated Kernodle would have a gathering every weekend or every other weekend and she would regularly attend. [REDACTED] stated she knew who the other people at the house or the people who would usually attend the gatherings.
3. [REDACTED] stated on November 3, 2022, she had gone over to Kernodle's apartment located at 1122 King Rd in Moscow, Idaho around 1 p.m. and was there for about 15 minutes. [REDACTED] stated everyone then left and went over to another apartment commonly referred to as the, "[REDACTED]" for a pre-game party. [REDACTED] stated her friends and Kernodle then went to another friend's house named "[REDACTED]" and her friends then attended the football game and Kernodle decided not to go. Following the game, [REDACTED] called Kernodle at approximately 7 p.m. Kernodle stated she and her roommates were at their apartment taking a nap and would decide later if they were going to go back out.
4. [REDACTED] stated when Kernodle would have get togethers she would usually invite men from the "[REDACTED]" and [REDACTED] fraternity house and girls from the "[REDACTED]" and Pi [REDACTED] sorority. [REDACTED] stated her friend group would also be invited. [REDACTED] stated it was usually the same people from each house that would come.
5. [REDACTED] stated she knew Kernodle occasionally [REDACTED]. [REDACTED] stated she wasn't usually around when she would [REDACTED].
6. [REDACTED] stated she had heard rumors of Kaylee having a stalker, but only had heard about it after the murders. [REDACTED] said the back door was always kept unlocked because the front door had a code and would usually lock automatically. [REDACTED] stated she heard of other rumors that one of the roommates had taken the dog out and someone jumped out of a tree at them. [REDACTED] said she heard another rumor that the killer entered the back door and was wearing a mask.
7. [REDACTED] stated after the football game she went home and eventually fell asleep.
