**Narrative**

- On November 18, 2022, at approximately 3:01 PM, Idaho State Police Detective Sergeant Beckner and I interviewed [REDACTED] regarding multiple homicides which took place in Moscow, Idaho. The interview took place at the Idaho State Police District 3 Office, located at 700 South Stratford Drive in Meridian, Idaho. During the interview, [REDACTED] stated the following:
- She lived at [REDACTED] Avenue in Moscow, Idaho. Her residence was in front of Madison MOGEN's house. She was no longer in a sorority, but she lived with some of the [REDACTED] sorority members.
- She knew Madison MOGEN, Kaylee GONCALVES, Xana KERNODLE. She had met Ethan CHAPIN but did not know him well. She was closest with MOGEN. She lived with [REDACTED] and [REDACTED].

previously. She went to MOGEN and GONCALVES residence often and was with them often.

4. She did not go out during the day on game day (Saturday, November 12th). She did not attend the daytime party, but she saw them at the bar that night. She went to the Corner Club with her friend [REDACTED] [REDACTED] and she found MOGEN and GONCALVES while she was there. She spent most of her time at the Corner Club with MOGEN and GONCALVES. She was supposed to go home with them, but she had a weird feeling, so she got a ride home with a freshman Greek life designated driver. She left at approximately 1:15 AM.

5. There was a weird man at the bar. He was pushing her at the bar. MOGEN introduced her to the man. The man was following MOGEN, [REDACTED] and GONCALVES around at the bar. MOGEN told [REDACTED] she had classes with the man. The man kept grabbing girls butts and he grabbed [REDACTED] stomach. He spat at them and others and [REDACTED] was told the man was kicked out of the bar. He never said much, he seemed off and not just drunk.

6. When she got home, she went to her friend's apartment also in the [REDACTED] which was directly across from MOGEN's residence. She did not hear or see MOGEN or GONCALVES come home, but she knew they went and got food at Grub Truck after they left the Corner Club. She saw GONCALVES post on Snapchat with MOGEN at the Grub Truck.

7. She went home to her apartment at 3:30 - 3:45 AM. There were not a lot of people arriving home around that time except for a few people belonging to the [REDACTED] fraternity, who were staying in the apartment where she was hanging out.

8. She knew there was speculation about [REDACTED] [REDACTED] [REDACTED] textured [REDACTED] at approximately 3:04 AM, to see what she was doing. [REDACTED] grew up with [REDACTED]

9. She has heard about a stalker, but she heard it could have been for any of the girls in that house. She has heard about a man that used to follow GONCALVES on her walks with her dog, and also had been seen around the dumpster.

10. MOGEN, GONCALVES and KERNODLE did not use drugs.

11. She spent a lot of time at MOGEN, GONCALVES, and KERNODLE's house. If she needed to borrow something, MOGEN would text her the door code, but they would often leave their back door open, so [REDACTED] would just walk around the back and go in often. Usually, the people who went to the victim's residence were known by other people in the group.

12. [REDACTED] doesn't usually go to house parties anymore, but KERNODLE and CHAPIN still attended them regularly because they were underage and could not go to the bar.

13. She didn't think any of them had any enemies.

14. She went to high school with [REDACTED] (not in the same grade), and she knew through Greek life. She did not know either of them well.

15. She knew MOGEN had a boyfriend, [REDACTED] [REDACTED] She knew GONCALVES had previous boyfriend, [REDACTED] and the current boy GONCALVES was seeing was [REDACTED] [REDACTED] [REDACTED] was really nice, and he and GONCALVES dated for approximately 6 years.

16. [REDACTED] left the Corner Club before

17. She recalled from previous years, there were people on the sex offender registry in the area.
