█/2002) in regard to the homicide of Kaylee GONCALVES, Madison MOGEN, Xana KERNODLE, and Ethan CHAPIN. The interview took place at the Idaho State Police District 3 Office, located at 700 S. Stratford Drive in Meridian, Ada County, Idaho. The following is summary of █ statement:

2. KERNODLE was one of █ closest friends outside her sorority, and █ knew CHAPIN through his fraternity. She was not very familiar with MOGEN and had never met GONCALVES.
3. Saturday before the incident was the last home football game, but there weren't a lot of people around because it was rainy. It was also Envision Idaho so there was not supposed to be alcohol on campus and there was not supposed to be a "Lodge Party," or an organized party at the █ lodge. █ went to the Lodge Party and there weren't many people there. Because Lodge Parties are sanctioned by Fraternity Sorority Life (FSL), █ kept a list of names of those in attendance at the party and check Vandal ID's.
4. There are apartments around the █ Lodge. █ went to an apartment, possibly apt. █ during the Lodge Party and KERNODLE was in the apartment. █ knew KERNODLE to party pretty hard and noted KERNODLE "wasn't super drunk that night." Another friend of █ took a photo of KERNODLE in the apartment playing guitar and posted it to her Snapchat story around 2 AM. █ took a screenshot of the post. █ recalled later in the interview also seeing KERNODLE's other roommate █ at the █ house.
5. The last █ spoke to KERNODLE at the █ house was approximately 12:45 AM. When everyone was leaving, KERNODLE and CHAPIN walked away and █ believed they went right home and did not go anywhere else. █ got a ride home from a █ "sober bro" named █ at approximately 2 AM. █ said █ also picked GONCALVES and MOGEN up from the Grub Truck and can be seen on the Grub Truck's live Twitch feed doing so. █ provided █ phone as █
6. █ went home at the █ house and was hanging out with some friends. The group went to the █ Pi house next door until approximately 4 AM before returning home and going to bed.
7. █ woke up at approximately 11 AM on Sunday to go study at the █ House.
8. █ said KERNODLE and CHAPIN were not big drug people and said she had not seen them use █. She stated KERNODLE █.
9. █ suspected someone would have been going after GONCALVES or MOGEN and "ran into" KERNODLE and CHAPIN. KERNODLE was one of the most popular girls in Greek Row and everyone knew and liked her. █ had heard GONCALVES had a stalker but did not know the validity of that rumor.
10. █ thought the Twitch broadcast didn't sit well with her. She said GONCALVES and MOGEN look really uncomfortable in the video. There is a male subject behind them that looked really nervous but █ did not know who the male was.
11. █ said KERNODLE's friend █ may know more about possible drama or conflict involving any of the victims.
12. █ said █ may be a primary source of █ on U of I campus and dated KERNODLE at some point. █ had also been kicked out of █ and was not currently attending U of I.
13. The interview was concluded at 3:00 PM. For complete details from █ statement, review notes and audio recording of interview.
14. I transferred the audio recording of the interview to a CD and submitted it into ISP Evidence under Tag #22000
15. On November 19, 2022, I received a text message from █. She told me a man by the name of █ had been stabbed in October in Kooskia, Idaho. No one was arrested for the stabbing and she made note of Kooskia's proximity to Moscow.
