<b>Narrative</b>		

1. On 11/16/2022 Idaho State Police Detectives Andy Hodl and Cody Herman were tasked with contacting [REDACTED] (DOB: [REDACTED]-1999) at phone number [REDACTED].
2. At approximately 1842 hours Detective Hodl and Herman made a recorded phone call (Herman recorder A2) to [REDACTED]. A female answered the phone and identified herself as [REDACTED]. [REDACTED] was asked what her relationship was with the victims, and she explained the following.
3. [REDACTED] was best friends with Madison Mogen. [REDACTED] and Mogen talked almost every day on multiple platforms (phone call, text, group text, snapchat, etc.) [REDACTED] used to live in the house on 1122 King Street with Mogen last year. [REDACTED] currently lives in Boise, Idaho.
4. [REDACTED] spoke with Mogen at approximately 1230 hours on 11/13/2022 via a facetime phone call which was between Mogen's phone and [REDACTED] phone. [REDACTED] phone number is [REDACTED]. The facetime call was very short and consisted mainly of, "We miss and wish you were here." During the call, [REDACTED] noticed that Mogen was outside of the Corner Club. [REDACTED] described Mogen's level of intoxication as buzzed but not falling drunk. [REDACTED] indicated she did not notice any red flags or odd behavior during the call.
5. [REDACTED] seemed to have a very detailed knowledge of the friends' group which the victims frequently associated with. [REDACTED] was asked if Mogen was in a relationship. [REDACTED] stated Mogen was currently dating a male named [REDACTED]. [REDACTED] reported the phone number for [REDACTED] to be ([REDACTED]). [REDACTED] described Mogen and [REDACTED] relationship to be very good and they loved each other very much. [REDACTED] stated Mogen and [REDACTED] had been together for approximately two years. [REDACTED] stated Mogen and [REDACTED] never fought. [REDACTED] stated [REDACTED] currently lives in Boise and was with her on the night of the homicides. [REDACTED] stated [REDACTED] and herself were downtown Boise from approximately 10:30 p.m. on 11/12/2022 to 02:00 a.m. on 11/13/2022 mountain time.
6. [REDACTED] also stated Kaylee Goncalves had been in a long-term relationship (6 years) with a male named [REDACTED]. She stated Goncalves and [REDACTED] had broken up about two weeks before Labor Day weekend 2022. She stated the breakup was a mutual break up and they both left on good terms. [REDACTED] stated [REDACTED] and Goncalves had a history of being on and off dating, but they did not have any history of fighting.
7. [REDACTED] stated the last time she was at the house (King Street) was on Labor Day weekend 2022 and that is when she really met Goncalves and became friends. Prior to that weekend [REDACTED] was primarily friends with Mogen.
8. [REDACTED] was informed she would be contacted soon for further interviewing and the call was terminated.
9. [REDACTED] contact information and a brief summary of the conversation was relayed to FBI victimology for follow-up.
