**Narrative**

1. On November 18, 2022, at approximately 12:16 PM, Homeland Security Investigations Task Force Officer (TFO) Sage Collins and I, Idaho State Police Detective Matt Wernsing, interviewed [REDACTED] (DOB [REDACTED]/2001) in regard to the homicide of Kaylee GONCALVES, Madison MOGEN, Xana KERNODLE, and Ethan CHAPIN. The interview took place at [REDACTED] boyfriend [REDACTED] home, located at [REDACTED] in Parma, Canyon County, Idaho. The following is a summary of [REDACTED] statement:
2. On Saturday, November 12, 2022, [REDACTED] was at [REDACTED] college house, located at [REDACTED] King Rd in Moscow, Latah County, Idaho. She called GONCALVES at approximately 10:00 PM and went over to her house. MOGEN came home from the [REDACTED] house shortly after.
3. GONCALVES had contacted a man by the name of [REDACTED] to give them a ride from their house. [REDACTED] did not know [REDACTED] last name, but provided his phone number as [REDACTED]. When [REDACTED] arrived to pick them up, GONCALVES got in the front seat and [REDACTED] and MOGEN got in the back seat. [REDACTED] had recently had a baby and [REDACTED] asked him "how fatherhood was." [REDACTED] said [REDACTED] was feeling down about it and let out a big sigh. He said it was harder than he'd expected and had been kind of hard on him. He also said his wife and kid were out of town and he was excited to have the house to himself for the weekend. [REDACTED] dropped the girls off at the Corner Club and told them he would be driving until about 3 AM.
4. [REDACTED] [REDACTED] [REDACTED] [REDACTED] and [REDACTED] were friends of the girls and were already at the bar. [REDACTED] told [REDACTED] he would also go to the Corner Club.
5. [REDACTED] and [REDACTED] shared a class with a guy named [REDACTED] who was also at the Corner Club. [REDACTED] began creeping [REDACTED] out by staring at her and making comments to her. [REDACTED] also spoke to [REDACTED] saying he needed "to get her [REDACTED] god damn phone number right now" and was being kind of aggressive. [REDACTED] hung around the girls at the bar for a while.
6. [REDACTED] said GONCALVES and MOGEN left to go to John's Alley in Moscow and heard [REDACTED] went with them. She didn't see him leave with the girls, but thought it would be weird if it was true. The girls had apparently asked [REDACTED] to go with them as well, but he stayed at the Corner Club.
7. [REDACTED] left the Corner Club with [REDACTED] at approximately 1:15 AM and went to the Grub Truck. They got food at the Grub Truck and went to [REDACTED] house at [REDACTED] in Moscow to eat and go to bed.
8. I asked [REDACTED] why it would have been odd for the girls to leave with [REDACTED]. She said [REDACTED] was not someone she or the other girls hung out with because he was weird. He smoked a lot of pot, had a temper and fought a lot. The girls knew [REDACTED] because he was a [REDACTED] or a member of the [REDACTED] fraternity. MOGEN's boyfriend was also a [REDACTED] and the sororities would often hang out with the [REDACTED].
9. GONCALVES and MOGEN had sent videos of themselves at the Grub Truck to a Snapchat group around 2 AM.
10. [REDACTED] had not heard of GONCALVES having a stalker. She said the victims were pretty well liked and did not know of any issues the victims had with anyone.
11. [REDACTED] thought [REDACTED] may have been working at the [REDACTED] the night of the incident, as well as [REDACTED] [REDACTED] and [REDACTED].
12. [REDACTED] said there were a lot of Instagram accounts that were surfacing. The accounts had few followers but were following many of the girls and making comments such as "you're next" "thank god they're gone" and "I'm going to do it again."
13. [REDACTED] thought [REDACTED] involvement with the sorority girls was odd. He would frequently drop other rides for them and gave them his personal phone number. He seemed to pay particular attention [REDACTED] members. This started with two sorority girls that had already graduated and had passed [REDACTED] phone number on to them.
14. The interview was concluded at 1:03 PM. For complete details of [REDACTED] statement, review audio recording of the interview.
