She believed the FBI had contacted individuals at the apartment already. 26. At approximately 11:46 a.m., the interview ended. 27. On December 5, 2022, Detective Tolleson contacted told Detective Tolleson he was not at King Street apartments the night of the homicide. I contacted to clarify if she knew for certain was at Kernodle's the day of the homicide. She told me she was mistaken. had been at apartment which was in the same area. 28. The recording of the interview, text message correspondence, and notes were turned over to the Moscow Police Department.
