**Summary Narrative**

Incidents 2228/2170. These are tips that were assigned to Detective Mark Hulet (Idaho State Police District 5 Investigations), on November 25, 2022 by Idaho State Police Detective Gideon Roberts (District 2 Investigations).

**Narrative**

Incident 2228/2170: On November 26, 2022, I Detective Mark Hulet (Idaho State Police district 5 Investigations), spoke with [REDACTED]. The phone call occurred around 11:08 AM. [REDACTED] phone number is [REDACTED]. [REDACTED] had submitted a tip regarding a man she had met on Tinder. [REDACTED] told me that she had met two times with [REDACTED] or [REDACTED] (fictitious names) at her apartment in Spokane Washington. [REDACTED] advised that both meetings were short in duration. [REDACTED] advised that the male she had met with was the same male as the male in the photos that she had submitted with her tip. [REDACTED] advised that apart from her tip, she didn't have any further information that wasn't mentioned. I asked [REDACTED] if she believed that the male could have some behavioral or mental issues. [REDACTED] told me that the male seemed very sound and very intelligent. [REDACTED] advised that the last time she had met with the male was Tuesday November 22. Kelly advised that the male had told her that he owns [REDACTED]. Note: Incident 2170 was the tip that Spokane Police Officer Adicts called in regarding [REDACTED] after he spoke with her. I advised Detective Schwecke of this information and these incidents at my level are closed, and further interviews will take place in person.

Note: The original tip papers for the above tips were left with Idaho State Police Detective Jake Schwecke. The tip papers contained [REDACTED] personal information. Detective Schwecke advised that the tip papers would be passed to the in person interviewer.

### Summary Narrative

I Detective Mark Hulet (Idaho State Police District 5 Investigations), maintained a running report as instructed while assisting Moscow Police Department with the homicide investigation of the University of Idaho students.

### Narrative

- On November 25, 2022, I Detective Mark Hulet (Idaho State Police District 5 Investigations), was issued incident #2228 and incident #2216. Detective Gideon Roberts (Idaho State Police District 2 Investigations) issued the two above incident numbers to me.
- On November 26, 2022, I was assigned the following incident numbers from Detective Jake Schwecke (Idaho State Police District 2 Investigations): 2152, 2137, 2156, 2159, and 2081.
- Incident 2216: On November 26, 2022, I called [REDACTED] [REDACTED] who had called in a tip. There was no answer, and I left a voicemail with my phone number. On the same day, [REDACTED] called me back and told me that what she had mentioned in her tip was what she had heard from her friends' granddaughters. [REDACTED] did tell me that she would try to get her friend to have her granddaughter call me to confirm if this was firsthand knowledge or if the information had been rumor. On November 27, 2022, around 16:38 hours, I called [REDACTED] [REDACTED] to follow up regarding our previous conversation and I left a voicemail. Later, the night of November 27, [REDACTED] called back and told me that she hadn't spoken to her friend yet. I relayed this information to Detective Schwecke and advised him that [REDACTED] only had 3rd party information and that this incident could be closed.
- Incident 2228/2170: On November 26, 2022, I called [REDACTED] [REDACTED] who had called in a tip regarding a man she had met on Tinder. I left a voicemail. Later the same day, [REDACTED] called me back. [REDACTED] told me that she had met two times with [REDACTED] or [REDACTED] [REDACTED] (fictitious names) at her apartment in Spokane, Washington. [REDACTED] advised that both meetings were short in duration. [REDACTED] advised that the male she had met with was the same as the male in the photos that she had submitted with her tip. [REDACTED] advised that apart from her tip, she didn't have any further information that wasn't mentioned. I asked [REDACTED] if she believed that the male could have some behavioral or mental issues. [REDACTED] told me that the male seemed very sound and very intelligent. [REDACTED] advised that the last time she had met with the male was Tuesday, November 22. [REDACTED] advised that the male had told her that he owns [REDACTED] [REDACTED] Note: Incident 2170 was the tip that Spokane Police Officer Adicts called in regarding [REDACTED] after he spoke with her. I advised Detective Schwecke of this information and these incidents at my level are closed, and further interviews will take place in person.
- Incident 2125: On November 26, 2022, Detective Spencer Knudsen (Idaho State Police District 5 Investigations) and I went to [REDACTED], located at [REDACTED], Moscow, ID 83843. The assistant manager, [REDACTED] was present and allowed Detective Knudsen and I permission to view their video footage. The view from a camera that showed White Ave., revealed no vehicles that matched the suspect vehicle. We also reviewed the video for the camera that shows Mountain View Road. There were no vehicles that matched the suspect vehicle present. This incident can be closed.

### Narrative

6. Incident 2137: On November 26, 2022, I called the [REDACTED] [REDACTED] [REDACTED] to set up a time to pick up their surveillance video. There was no answer, and I left a message. Later, the same day Detective Knudsen and I went to the [REDACTED] [REDACTED] [REDACTED] located at [REDACTED] in Moscow. A sign on the management door advised that the office is open Monday through Friday. On November 28, 2022, Detective Knudsen and I went to [REDACTED] [REDACTED] [REDACTED] and met with [REDACTED] [REDACTED]. We looked at the only camera at the front of the store. [REDACTED] advised that this camera shows the crosswalk area directly in front of the front door and advised that there weren't any other views. This information was reported to Detective Schwecke and this incident was closed.
7. Incident 2156: On November 26, 2022, I called the phone number on the tip and left a voicemail regarding setting up a time to retrieve the video surveillance. On November 28, 2022, I spoke with [REDACTED] on the phone. [REDACTED] advised that he checked his video surveillance for the needed date and times and that it didn't show any traffic on the highway past his business. I relayed this information to Detective Roberts and this incident was closed.
8. Incident 2081: On November 26, 2022, I called the phone number on the tip. There was no answer, and I left a voicemail. This was to confirm whether the caller had been able to upload his video footage using the link that he had been provided. On November 28, 2022, around 8:32 AM, I spoke with [REDACTED] [REDACTED] [REDACTED] advised that he was able to upload his video to the FBI link. I relayed this information to Detective Roberts and this incident is closed.
9. Incident 2159: On November 26, 2022, I was able to get into contact with [REDACTED] who is over the security camera system at [REDACTED] located at [REDACTED] in Moscow. [REDACTED] advised that he will contact the store and let them know that we would be coming to look at video footage. Detective Knudsen and I went to [REDACTED]. We were advised that they were unable to log into their program and to come back on Monday, November 28, to get the video footage. On November 28, 2022, Detective Knudsen and I went to [REDACTED]. We met with [REDACTED] the store manager and she allowed us to look at video surveillance. I downloaded two small videos of white passenger cars that were driving north. I turned the USB drive over to Detective Schwecke and this incident is closed.
10. Incident 2200: On November 26, 2022, I was assigned this incident by Detective Schwecke. The caller is anonymous. I called the phone number on the tip and left a message. The call was made November 26, at 2:09 PM. On the same date at approximately 7:02 PM, I had a missed call from the phone number attached to this incident. I called the phone number back on November 27, at 11:10 AM and left a voicemail. On November 27, 2022, around 5:41 PM, the anonymous tip caller returned my phone call. This person advised that [REDACTED] was very close to the victims and survivors and that she had previously been at the residence the homicides occurred at but left prior to. This person provided me with the phone number for [REDACTED] stepmom, [REDACTED]. This caller wanted to remain anonymous. On November 28, 2022, around 9:10 AM, I called the phone number for [REDACTED] and left a voicemail. At 9:20 AM on the same day, [REDACTED] [REDACTED] stepdad called me regarding the voicemail I had left [REDACTED]. [REDACTED] provided me with [REDACTED] phone number. On November 28, 2022, around 9:34 AM, I called [REDACTED]. During the conversation, I wrote down her date of birth, her address and phone number. I told [REDACTED] that a detective from Boise would reach out to her to set up an in-person interview. [REDACTED] was very willing to speak and help. I provided Detective Schwecke this information and this incident is closed on my end; the information will be passed along for an in-person interview.
11. Incident 2528: On November 26, 2022, I was assigned this incident by Detective Schwecke. This tip is regarding a [REDACTED] [REDACTED]. A photo of a male with a beard was at the Grub Hub in Moscow around the approximate time that the victims were also at the Grub Hub. The male in the photo had a large knife on his hip. On November 27, 2022, at approximately 11:40 AM, Detective Knudsen and I conducted an interview with [REDACTED] [REDACTED] at his residence in Pullman, WA. During the interview, [REDACTED] advised that he had interviewed for a job at [REDACTED] on November 9, 2022 and hadn't been back to [REDACTED] since. [REDACTED] advised that he doesn't go out to bars and when asked about the Grub Hub, he advised that he didn't know what that was. [REDACTED] advised that he does not carry a large knife on him and proceeded to show us a small pocketknife that he had on his person. [REDACTED] advised that he had a few other larger collection knives. I saw two of the knives and [REDACTED] advised that the other one was a sword. [REDACTED] is approximately [REDACTED] and around [REDACTED] plus pounds. He was not a match for the person who was in the Grub Hub photos. I reported this information to Detective Schwecke that [REDACTED] [REDACTED] was not a match of the male in the photo, and that he did not match the description of the suspect. This incident was closed.

### Narrative

12. Incident 1345: On November 26, 2022, I was assigned this incident by Detective Schwecke. This tip was reference to a few social media accounts regarding photo time stamps. Nothing else was requested. On November 27, 2022, I reviewed the requested material and nothing of importance was noted. This information was reported to Detective Schwecke and this incident was closed.

13. Incident 3164: On November 27, 2022, I was assigned this incident by Detective Schwecke. This tip was in poem form and a GPS coordination was provided for a location to check out. Detective Knudsen and I went to the coordinates provided and it was an empty muddy field. There were no recent footprints or tire marks. I reported this information to Detective Schwecke and this incident was closed.

14. Incident 0775: On November 27, 2022, I was assigned this incident by Detective Schwecke. This tip was to obtain video footage from an [REDACTED] who owns a store at [REDACTED], in Moscow. I called [REDACTED] and left a voicemail on November 27, at 12:45 PM. On November 28, 2022, I called [REDACTED] and left a voicemail. Later, the same day at 12:00 PM, I called and left another voicemail. On this voicemail, I provided the FBI video link so that [REDACTED] could upload his video. I reported this to Detective Schwecke and this incident is closed.

15. Incident 2041: On November 27, 2022, I was assigned this incident by Detective Schwecke. On this tip, there was information regarding video footage from [REDACTED], in Moscow. The caller was [REDACTED]. On the same date, I contacted [REDACTED]. [REDACTED] advised that the tip wasn't to obtain video footage, but to let police know that he was on his way to the airport on the day of the homicides and was near the intersection of Taylor Ave., and Blake Ave., and didn't see anyone out and about. [REDACTED] advised that he drove through the area between 3:55-4:00 AM. No further on this incident. I advised Detective Schwecke and this incident was closed.

16. Incident 2813: On November 27, 2022, I was assigned this incident by Detective Schwecke. Phone information from one of the occupants involved in the homicide investigation showed them using their [REDACTED] app on November 12, 2022. On the same day, Detective Knudsen and I went to the [REDACTED] located at [REDACTED] in Moscow. We met with [REDACTED] who was the manager for that day. [REDACTED] said that he didn't have access to the video. I provided him my business card. On the same day, [REDACTED] called me and advised that he sent me an email with a link to submit a video request to the corporate offices of [REDACTED]. I advised Detective Schwecke of the link and he told me to email him the link and he would forward it on to those who would need the video. I forwarded Detective Schwecke the email with the link and this incident was then closed on my end.

17. Incident: 2519: On or around November 28, 2022, around 2:00 PM, Idaho State Police Detective H. Powell and I conducted an interview with [REDACTED] in his apartment located at [REDACTED] in Moscow, Idaho. During the interview, [REDACTED] had a calm demeanor. [REDACTED] appears to be [REDACTED] and weighs around [REDACTED] lbs. [REDACTED] advised that the day of November 12, he was home most of the day and took his dog out a few times to use the bathroom. The night of November 12, he was home alone with his dog and advised that he went to bed around 11:30 PM. [REDACTED] advised that he doesn't go out to the bars often unless he is invited by his friends. [REDACTED] advised that on Sunday morning the 13th, he woke up around 8:00 or 9:00 AM. [REDACTED] advised that a shelter in place came into effect around 1:00 PM. [REDACTED] advised that he walked his dog down the road past the victim's home, which is where his dog uses the bathroom. [REDACTED] advised that he walked past the homicide house and didn't notice anything off about the home and he believed that the door was closed. [REDACTED] advised that later the 13th, between 4:00 and 6:00 PM, he left to go and do laundry. [REDACTED] advised that his first contact with law enforcement was around an hour after the shelter in place went into effect. [REDACTED] advised that after doing laundry, he stayed home for the rest of the evening. [REDACTED] advised that he is a [REDACTED] at the U of I. [REDACTED] advised that he knew that people on social media and on the internet were accusing him of the crime. [REDACTED] advised that he would be willing to provide a DNA sample to clear his name. [REDACTED] also advised that he didn't know any of the victims. On 12/5/2022, I downloaded the recording and copied it onto a CD. The CD will be mailed with the report packet to Moscow PD.

18. On or about November 29, 2022, Detective J. Schwecke forwarded an email tip to Detective L. Edgley regarding [REDACTED] employees who were potentially working the night of November 12, 2022. Detective Edgley forwarded the email to me for completion. On the same day, I was in contact with the following: [REDACTED] [REDACTED] [REDACTED] [REDACTED] and [REDACTED] [REDACTED]. Instead of speaking with [REDACTED] I spoke with [REDACTED].

### Narrative

██████ who advised that ██████ is his fiancé, and he does ██████ under her account name. All parties involved advised that they do not have a dash camera on their vehicles. All further advised that none were in the area at or around the time of the incident. Further, all advised that they had not observed anything suspicious that stood out to them. This information was relayed to Detective Schwecke and this incident was closed on my end. I didn't receive the tip numbers for this.

19. Incident 4465: On or about November 30, 2022, around 10:05 AM, I spoke with ██████ ██████ to inquire if any of the ██████ had dash cameras. ██████ told me that there aren't any dash cameras on the vehicles. ██████ further advised that due to short staffing, the area where the homicides took place, and the neighborhood around that area hadn't had a ██████ for around 3 months. This information was passed on to Detective Roberts and this incident was closed.
