Narrative

2. She lived at [REDACTED] King Rd across the street from the 1122 King Rd house. One of the people across the street was a former sorority sister, one was a classmate, and the other two were people she knew through mutual friends. She knew (Madison) MOGEN and (Kaylee) GONCALVES the best.
3. Her boyfriend was best friend's with MOGEN's boyfriend ([REDACTED] [REDACTED]) so they hung out a lot. This was a current relationship. MOGEN was in a class with her.
4. GONCALVES was an [REDACTED] sorority sister.
5. She knew (Xana) KERNODLE and (Ethan) CHAPIN in passing.
6. She has lived at [REDACTED] King Rd for just the semester and is currently a senior in school. She lived in the sorority house for three years and this is the first year outside of the sorority.
7. She has been inside the 1122 King Rd house multiple times with the last time being in September. They came over to her house more often.
8. She had known MOGEN and GONCALVES for three years. They met through recruitment.
9. She saw MOGEN and GONCALVES Saturday night (November 12th). They went to the Corner Club after the game. MOGEN and GONCALVES were already there when she arrived. She was there for a couple of hours and was really drunk. She left before MOGEN and GONCALVES. It was sometime around midnight.
10. GONCALVES had jokingly mentioned she thought she had a stalker at Winco. It had happened once and was an unknown person.
11. She heard from another friend an instance of the house door at 1122 King Rd being open after all the roommates returned from a weekend trip.
12. She has a basement room and can see the 1122 King Rd house from it. She woke up at 9:00 AM on Sunday morning. She didn't hear or see anything that night.
13. 1122 King Rd didn't have a party on Saturday night. They may have had one on Friday but it wasn't crazy.
14. MOGEN and [REDACTED] were a solid couple and had dated for a year. [REDACTED] was with her boyfriend in Boise that weekend.
15. The interview concluded at 12:52 PM.

- On November 18th, 2022, at approximately 11:55 A.M., Idaho State Police Detective Chris Pohanka and I interviewed [REDACTED]. The interview took place at [REDACTED] residence, located at [REDACTED], Buhl ID 83316.
- [REDACTED] relayed to us the following:
- He is roommates with [REDACTED]
- He has known Kaylee since Freshman year. They were in the same pledge class. So, they've hung out together periodically over the last four years. He has visited her house in Coeur D'Alene once.
- He knew Xana as well but not as well as Kaylee. He also knew Maddie as well but they didn't hang out a lot.
- Kaylee and [REDACTED] had been dating since high school. They're on and off and have broken up twice. They had recently broken up because she accepted a job in Dallas. So, they were settling things before she left after the semester. They broke up about two months ago.

7. He never heard from Kaylee about anyone stalking her or giving her bad vibes.
8. He had heard there was someone following her out of Winco a couple months ago. He heard from friends she had someone follow her out of the Winco to her car. He heard that story from [REDACTED] (a sorority sister of Kaylee's). [REDACTED] is in California right now and her phone number is [REDACTED].
9. He works at [REDACTED] in Moscow so he saw Kaylee, Maddie, and [REDACTED] leave [REDACTED] together that night. That was the last time he saw them.
10. They said they were going to John's Alley and were trying to get some friends to go with them. They didn't end up going there though. He didn't know where they were before they showed up at [REDACTED].
11. He had seen Xana at some parties but didn't really know her very personally. He tried to recruit Ethan into his fraternity, but otherwise didn't really know him.
12. He doesn't know of anyone who might have wanted to hurt any of them. They were all really nice people.
13. [REDACTED] wouldn't have harmed Kaylee. He loves her and thought they would be married. They have a great relationship even when they were not together. He is a calm and kind person. He's into sports, not an outdoorsman. He doesn't have a knife. He has never heard [REDACTED] even say anything bad about Kaylee.
14. There is an apartment complex behind the victim's house that has a lot of "sketchy" people in it. There are registered sex offenders living in it. That place is behind [REDACTED] apartments. There are windows facing the girls' house and it's adjacent to it. It's a brown brick apartment complex.
