An hour after receiving the first "Vandal Alert" he received another which told him there was no suspect and to remain vigilant. A third "Vandal Alert" was sent out that evening while he was at work which had details of how many victims there were.
- 10. He didn't know Mogen was one of the victims until Monday afternoon when he received an email from his

professor of Marketing He, Mogen, and are in marketing at the University and worked together on group projects. They were working on a project for which was a café in town Mogen worked for. When they worked on projects together, they would meet and work in basement of the Albertsons building on campus. He hadn't ever been to Mogen's house and didn't know until recently where she lived.
11. He worked at in Moscow and has worked for for eight years in total. As he transferred colleges, he moved stores with His boss said the store carried old Ka-Bar knives, but they were an older clearance item. He didn't know what kind of sheath a Ka-Bar knife would come with.
12. He didn't know Kaylee Goncalves and didn't remember seeing her at the Corner Club. He didn't know any of the victims besides Mogen.
13. Mogen was the only person from the house he spoke with, and it was mainly related to class projects. He'd only talked to Mogen approximately four or five times throughout the school year. They mainly used text messaging to communicate. He read us the group text he, Mogen, and Mogen was the photo and text message at the Corner Club.
14. He was attending his last semester at the university, and he thought Mogen was going to finish in 2023.
15. He started college at Treasure Valley Community College, transferred to Utah Tech University, and from 2017 to 2019 he started attending the University of Idaho. In 2019 he joined the Army Reserve as a culinary specialist. After two years he went back to the University of Idaho to finish his schooling.
16. He never heard of any issues Mogen had with anyone. He did not know if Mogen used any narcotics. They never spoke of anything personal.
17. He didn't have a car and walked wherever he needed to go around the campus. He road the bus home to Boise and barrowed his brother's pickup while he was in town.
18. did not have any injuries to his hands, arms, or face.
19. At approximately 1:36 P.M., consented to a DNA sample. Idaho State Police Detective Millar arrived on scene and collected a DNA sample from which I took custody of and submitted it into evidence for processing.
20. At approximately 1:38 P.M., we concluded the interview.
