**Narrative**

1. On December 1, 2022, Idaho State Police Detective T. Snell, and I, Detective Sergeant J. Stennett, obtained two archival CDs and receipts associated with the November 9, 2022, purchase conducted by Kaylee Jade Goncalves (DOB [REDACTED]/2001) at the [REDACTED] [REDACTED] [REDACTED] [REDACTED]. Refer to incident #4706 Kaylee's purchase at [REDACTED].
2. Video footage of the purchase inside of the [REDACTED] shows Goncalves purchasing a fountain drink at approximately 19:03 hours and exiting the store. The most likely vehicle Goncalves departed in appeared to be a dark colored mid-size SUV. The vehicle was associated with the purchase of \$60.00 in fuel on pump #1 at approximately 18:59 hours.
3. The credit card used to conduct the purchase of the gas was associated to [REDACTED] Goncalves.
4. The receipts and the archival CDs were turned over to the Moscow Police Department.
4. The investigation is ongoing.
