- A. They met while they both worked together at [REDACTED] approximately 5 years ago.
- B. He has been roommates with [REDACTED] off and on for the past couple of years but most recently a little less than a year. The other two roommates in the house were [REDACTED] [REDACTED] and [REDACTED] [REDACTED] and [REDACTED] were a couple.
- C. He has never known [REDACTED] to have a girlfriend since they have known each other but knows of a former girlfriend named [REDACTED] [REDACTED] who he dated in high school. She now lives in Portland, Oregon.
- D. On November 12, 2022, from approximately 9:30 P.M. to 10:00 P.M. he and [REDACTED] went to Mingles after attending a dart tournament at the Moose Lodge earlier in the day. Shortly after 11:00 P.M. they left Mingles and went to The Corner Club. Both he and [REDACTED] were drunk. He met with a girl named [REDACTED] [REDACTED] while at the club around 11:30 P.M. and did not see [REDACTED] the rest of the night. He was unaware of who [REDACTED] was talking or hanging out with at the club.
- E. On November 13, 2022, he got home around 1:24 A.M. and went to [REDACTED] room and saw he was passed out. He was surprised to see him home so early because he normally shuts down the bar.
- F. He has known [REDACTED] to get flirty and handsy with girls when he gets drunk. He was unaware of [REDACTED] being kicked out of The Corner Club earlier that night.
- G. Sunday evening they talked about the incident and he remembers [REDACTED] mentioning that he had a marketing class with one of the girls (Madison Mogen).
