- B. The digital numerical keyless entry, located on the front door had codes: 1: Programming, 2: Maintenance, 3: "Code A" (primary code given to occupants), and 4: "Code B" (used if an occupant was locked out by accident). Occupants could provide the door code to whoever they chose.
- C. The keyless entry was maintained by of Moscow, Idaho. It was last serviced on October 19, 2020.
 - D. The keyless entry was not wifi or Bluetooth enabled and did not keep a log of entries.
