Narrative

1. I, Idaho State Police (ISP) Detective Brady Walker, conducted phone interviews regarding this case. Refer to the narrative of the report for the summary of what the following individuals provided.

2. I contacted [REDACTED] (unknown complete name or DOB) on 11/16/2022 at 1845 hours at [REDACTED]. [REDACTED] wished to report a suspicious interaction her husband (unknown further) had with a male earlier that day. [REDACTED] informed me the Moscow Police had taken the call, contacted the male, and released him after their interaction.

3. I contacted [REDACTED] (DOB [REDACTED]/2001) on 11/16/2022 at 1946 hours at [REDACTED]. [REDACTED] was in the [REDACTED] as Gonçalves and Mogen but said they had dropped last semester. She mentioned a male named [REDACTED] (believed DOB of [REDACTED]/2001) that was fairly violent and got into a lot of fights. Mogen and Gonçalves associated sometimes with [REDACTED] as recently as October 2022, but [REDACTED] believed [REDACTED] had gotten kicked out of U of I. She knew that Mogen's ex-boyfriend was named [REDACTED] and her current boyfriend was [REDACTED]. Mogen stayed in touch and talked to [REDACTED] and [REDACTED] did not like that. [REDACTED] believed Mogen still possibly had feelings for [REDACTED].

4. I contacted [REDACTED] (DOB [REDACTED]/2001) on 11/18/2022 at 1030 hours at [REDACTED]. [REDACTED] roommate, [REDACTED] had a best friend named [REDACTED]. [REDACTED] had relevant video from the area at the time of the incident.

5. With the previous information, I contacted [REDACTED] (DOB [REDACTED]/2001) on 11/18/2022 at 1053 and 1107 hours at [REDACTED]. [REDACTED] informed me that her friend, [REDACTED] lived near 1122 King Road in Moscow and had surveillance video of someone leaving the area around the time of the incident. In the follow-up call, [REDACTED] told me there was a homeless man with a beard and a limp that lived in the area of [REDACTED] where Gonçalves and Mogen were spotted. She said the male in [REDACTED] surveillance video appeared to have a beard and a limp as well. [REDACTED] also told me she had heard through a friend that Kernodle commented on someone's TikTok video around 0400 hours the night of the incident. I asked [REDACTED] to find out where that information had come from and to relay that to me. She said she would try to find the source of the information.

6. With the previous information, I contacted [REDACTED] (unknown complete or DOB) on 11/18/2022 at 1101 hours at [REDACTED]. [REDACTED] informed me she had surveillance video of a male leaving the area. After talking to her, I confirmed that the video was taken from a light-socket powered camera and that Moscow Police had already secured the camera.

7. I contacted [REDACTED] (DOB [REDACTED]/1982) on 11/18/2022 at 1552, 1650, and 1711 hours at [REDACTED]. Completion of this follow-up took several phone calls, and this will summarize our interaction. I had previously received information from another source that Gonçalves potentially had a "stalker", or someone interested in her without reciprocation. [REDACTED] operates [REDACTED] (Moscow) where Gonçalves was employed 06/03/2022 until 07/16/2022. [REDACTED] did not recall a time where Gonçalves was made uncomfortable by any employee or patron. He contacted current employees and the assistant manager; he did not discover an instance where that happened. [REDACTED] said that a male named [REDACTED] (born in 1998) had asked for a highlighter on 08/22/2022. When he was provided one by restaurant staff, he said he wanted to "destroy his face" and began drawing on himself. He was trespassed by police on 08/26/2022. On the night of November 12,

█████ left the restaurant late around 0135 hours. He took a taxi home, where his "other half" was, and stated his home video system shows him at him there until late morning on November 13. ██████████ was ██████████ ██████████ provided the phone number for ██████████ and said he had been good friends with Goncalves, Mogen, and Kernodle.

8. I contacted ██████████ (DOB ██████████/1999) on 11/18/2022 at 1618 hours at ██████████ ██████████ met Goncalves in 8th grade, Mogen in 8th grade, and Kernodle his junior year of college. He was friends with all of them but was closest with Kernodle. In fact, ██████████ met his girlfriend, ██████████ through Kernodle. ██████████ graduated University of Idaho spring ██████████ and has never been to 1122 King Road. He had heard that a male had been following female employees in the back parking lot at ██████████ (That was debunked in the conversation with ██████████ ██████████ had a friend named ██████████ who was in Moscow the weekend of the murder. ██████████ told ██████████ he was going to walk Goncalves and Mogen home but did not because they went to a frat party, which he could not attend as he was not a student. ██████████ provided number was ██████████.

9. I contacted ██████████ (DOB ██████████/2000) on 11/19/2022 at about 1818 hours at ██████████. ██████████ knew Goncalves, Mogen, and Kernodle from school and living in north Idaho. He lives in the Coeur d'Alene area and had gone to Moscow on 11/12/2022. He texted Mogen on 11/12/2022 but was never with her in person. His last text contact with her was on 11/12/2022 at 1946 hours. He did not have contact with Goncalves or Kernodle that night. He was not able to attend the fraternity party because he was not a student. ██████████ thought perhaps he could have prevented this incident if he had partied with the girls, because he would have walked them home, but was not physically with them that night. On the night of the 11/12/2022, ██████████ was at a party near ██████████ apartments. He did not specify where exactly the party was held. ██████████ mentioned he heard Goncalves had been followed by a strange male (or a similar incident). ██████████ did not have first-hand knowledge of this incident.

10. I tried to contact ██████████ (DOB ██████████/2003) on 11/19/2022 at about 1816 hours at ██████████. ██████████ did not answer but called me back at about 1829 hours. ██████████ was roommates with Ethan Chapin last year and was currently a roommate of ██████████. He had daily contact with Chapin, who would commonly come over to play Xbox with ██████████. ██████████ was one of Chapin's best friends. ██████████ had known Kernodle since before she and Chapin started dating. ██████████ didn't really know Goncalves or Mogen. ██████████ identified his girlfriend as ██████████, and he provided a phone number of ██████████. ██████████ had gone to 1122 King Road a few times this year. On November 12th, ██████████ attended the Formal party and went to the ██████████ party afterwards. He left the ██████████ party around 0100 and went to a party at the ██████████ apartment building accompanied by ██████████ and ██████████. The apartment unit they went to was referred to as ██████████. They were at the ██████████ until about 0500 hours when they returned to their unit at ██████████. They went to bed around 0530. ██████████ had no contact with Chapin since the Formal and did not have any contact with Kernodle that day.

11. I tried to contact ██████████ (DOB ██████████/2004) on 11/19/2022 at 1850 hours at ██████████ but he did not answer. ██████████ called me back on 11/25/2022 at 1013 hours. ██████████ is a roommate of ██████████. ██████████ was friends with Chapin and saw him daily. Chapin's best friend in their ██████████ fraternity was ██████████. Chapin would come to the fraternity house and play Xbox with ██████████ almost daily before class. ██████████ had only been to 1122 King Road a couple of times. ██████████ had gone to the Formal event on the night of 11/12/2022. ██████████ left the Formal event and got back to ██████████ around 2030/2045 p.m., where there was an after-party event. The party took place in a common room. He spoke with Chapin once at the after-party. ██████████ left ██████████ around 0115 hours on 11/13/2022. He went to a party at the ██████████ top right apartment with ██████████ and ██████████. There were at least two males at the apartment, and ██████████ believed their names were ██████████ and ██████████. They stayed there until about 0330/0400 hours, when they went back to ██████████. They all went to bed around 0415. ██████████ said his timelines towards the end of the night were estimates due to his consumption of alcohol.
