2. [REDACTED] reported the following during the interview:
3. She knew [REDACTED] [REDACTED] for approximately 6 years from going to high school together.
4. On November 17, 2022, she had beers at Prost with [REDACTED] [REDACTED] [REDACTED] [REDACTED] and other friends. [REDACTED] [REDACTED] kept to himself and didn't talk much, this was not abnormal for [REDACTED] [REDACTED]. She stated [REDACTED] [REDACTED] was stressed due to a reported showing up at his house.
5. She saw [REDACTED] [REDACTED] on November 25, 2022 at Amsterdam Lounge while she was there with her parents.
6. [REDACTED] [REDACTED] was asked if she thought [REDACTED] [REDACTED] or [REDACTED] [REDACTED] could have committed the murder. She said there is no way either of them could have done it.
7. At approximately 3:05 P.M., we concluded the interview.
