- On November 18, 2022, at approximately 12:28 P.M., Idaho State Police Detective Sergeant David Cortez and I, Detective Chris Pohanka, interviewed [REDACTED]. The interview took place [REDACTED] in Buhl, Twin Falls County, Idaho.
- I called and arranged with [REDACTED] to come speak with her about the homicide in Moscow, Idaho.
- I asked [REDACTED] how she knew the victims in Moscow. [REDACTED] explained how Kaylee (GONCALVES, victim) belonged to the [REDACTED] Sorority. GONCALVES resigned from the Sorority, [REDACTED] and GONCALVES still remained friend. "Madi" (Madison MOGEN, victim) was one of GONCALVES best friends.

**Narrative**

MOGEN was in classes with [REDACTED] friend [REDACTED] [REDACTED] [REDACTED]. The girls would work on group projects at [REDACTED] Sorority. [REDACTED] knew Xana KERNODLE (victim) through mutual friends and knew Ethan CHAPIN (victim) the same way.

4. [REDACTED] is still in the Sorority but does not live in the Sorority house. [REDACTED] lives in a house which overlooks the back yard of GONCLAVES. [REDACTED] describes how her room looks directly to the sliding door of GONCLAVES house.

5. I asked [REDACTED] if she was around the victims the night of the homicide. [REDACTED] was with her friends [REDACTED] and [REDACTED] and began their night at John's Alley (114 E 6th Street, Moscow, Idaho). [REDACTED] took a phone call from GONCALVES to come down to the Corner Club (202 N. Main Street, Moscow, Idaho). [REDACTED] and her friends went to the club. [REDACTED] friends slowly left from there and went back to their houses. GONCALVES and MOGEN were still at the club with [REDACTED] GONCALVES and [REDACTED] were planning on going to John's Alley to continue the evening. [REDACTED] was talking to another friend and noticed GONCALVES and MOGEN had left. [REDACTED] went to Grub Truck (Grub Wandering Kitchen, no set location, Moscow area), and believed she was about a half hour behind GONCALVES and MOGEN at the truck. [REDACTED] even had the same LYFT driver as GONCALVES and MOGEN.

6. Sergeant Cortez asked if she had any further contact with the girls and she didn't. [REDACTED] and [REDACTED] fell asleep in [REDACTED] room. She went to [REDACTED] room for the night. She thought she remembered hearing music but was not sure. She would have been able to hear if they were having a party.

7. [REDACTED] got a video from her friend [REDACTED] of [REDACTED] on her bed snoring. [REDACTED] tried to listen to the video to see if she could hear anything in the background and she couldn't.

8. Sergeant Cortez asked if she was aware of where they were before the Corner Club. [REDACTED] thought they might have come from their house. Thursday night GONCLAVES wanted them to go out. Saturday night everyone was out. She said the girls usually like getting ready together.

9. Sergeant Cortez asked if she was aware of where they were Friday and she remembered there was a game. She thought a couple of them went to the game but was not sure. A couple of them went out later.

10. Sergeant Cortez asked if she knew where they were Friday and [REDACTED] knew Thursday night was asleep over night at the [REDACTED] house. GONCALVES was not able to attend since she resigned from the sorority. She thought GONCALVES was in Coeur d'Alene, Idaho and she told her to come back. She thought GONCALVES came back Friday and showed people her car. She did not believe they did anything Friday night.

11. Sergeant Cortez asked is GONCALVES ever mentioned anything about a stalker. [REDACTED] described GONCALVES as a person who would just joke things off. She believed there could have been a time where she mentioned something. When recruitment for the sorority was over, GONCALVES went over to [REDACTED] house. They were talking and catching up. She thought she mentioned something, but GONCALVES pushed it off as a joke. She could not remember anything specific from the conversation since it didn't seem like a big deal. [REDACTED] thought if GONCALVES would tell anyone about something strange like a stalker, would be her ex-boyfriend [REDACTED] or MOGEN. [REDACTED] and GONCALVES grew up together and shared a dog, "Murphy" together.

12. Sergeant Cortez asked [REDACTED] if GONCAVLES said anything once her and [REDACTED] broke up if he would want to hurt her. GONCALVES described [REDACTED] to her as, "Her child" and was not a serious guy. [REDACTED] was in [REDACTED] Fraternity, and they all hung out together since they lived next door. She describes GONCLAVES and [REDACTED] as a "brother and sister" relationship. They shared Murphy the dog. Sergeant Cortez asked her if she thought [REDACTED] would do anything to hurt her and she believed he would never do anything to hurt her. [REDACTED] was described as, "A city guy" and she did not think he did a lot outdoors. He was from the Coeur d'Alene area and grew up with sisters.

13. Sergeant Cortez asked [REDACTED] if she knew anyone that might have wanted to hurt them in their circle of friends, she said, "Their circle is interesting and that's where it kinda stumps everyone..... Because this group of people would probably never have been friends if it wasn't for the housing situation". All of the roommates friends would meet each other and have friends hang out with friends.

14. Sergeant Cortez asked if there was any mention of strangers around the house, ██████ spoke about one of the prior tenants to the house. The house had a weird feeling to it however it was from several months ago.
15. Sergeant Cortez asked her if she heard anything the night of the homicide and she normally would. They were referred to as the "party house" and would normally hang out in the back yard and play loud music. The night of the homicide, everyone had gone elsewhere to hang out. The sliding back door was considered the front door to the people who would visit. She didn't know if the back door was locked or unlocked. ██████ talked about how the kitchen area/ living area was the main place for them to hang out. The door was usually open for people.
16. She did not know of any large knives in the house.
17. Sergeant Cortez asked ██████ if GONCLAVES told her about someone following her at the WinCo. She had not heard anything of the story.
18. Sergeant Cortez asked ██████ if she knew of anyone we should talk to and she was having a hard time recalling anything. She talked how GONCLAVES and her would go out randomly and could not think of anyone to talk to.
19. Sergeant Cortez asked her if she knew of anyone GONCLAVES was romantically involved with after ██████ named ██████ and a ██████ who are both '█████'. She did not have any contact information. She did not believe any of the males mentioned would have anything to do with the homicide.
20. I told her if she can think of anything to assist the investigation to call. She mentioned how she would hear the dog "Murphy" bark and she never heard him bark that night. ██████ had the television on and thought she had gone to bed around "3:30 A.M.". She would be able to hear anything going on in the house since the windows are really thing. ██████ could even hear conversations in the back yard.
21. Sergeant Cortez asked if the other roommates would have anyone who would want to hurt them. She thought everyone in the house were amazing people. GONCLAVES boyfriend ██████ was in Boise. She spoke very highly of him. KERNODLE and CHAPIN were in a newer relationship and usually partied with the ██████. KERNODLE knew a lot of people and did not have any enemies.
22. ██████ and her friends created Instagram accounts and have their profiles private. Lately they have been getting a lot of traffic. She added people can make a fake profile and it would be an easy way to stalk people. She mentioned a profile which had a pretty girl as the profile picture. The profile had been around for a long time. The name on the profile was ██████ she did not know if the profile was real or fake.
