**Narrative**

1. On November 18, 2022, at approximately 11:08 AM, Idaho State Police investigations Lieutenant Catlin and I, interviewed [REDACTED]. The interview took place at the Idaho State Police District 3 Office in Meridian, Idaho. Her father, [REDACTED] was present for the interview. During the interview, [REDACTED] stated the following:

2. She lived at [REDACTED] in Moscow, Idaho, during the incident. Her backyard abutted the 1122 King Road

backyard. She knew Maddison MOGEN, Kaylee GONCALVES, and Xana KERNODLE. She did not know Ethan CHAPIN. She was closest with MOGEN and GONCALVES.

3. She was in the [REDACTED] sorority with GONCALVES. The rest of that house was in the [REDACTED] sorority. GONCALVES had dropped the sorority house membership that year due to financial cost.

4. GONCALVES was out of town most of the week but had decided to come back near the end of the week to go to the Pi [REDACTED] formal on Friday (November 11th) with one of her roommates. Friday night, GONCALVES had asked her to go to the club, which she did not. She did go out Saturday to a game day celebration at about 2-2:30 PM at the big [REDACTED] apartment. She left and went to the game at approximately 4:40 PM, while GONCALVES and MOGEN stayed at the party.

5. Saturday night, she went to the Dirty Goat, a local bar. GONCALVES contacted her and wanted her to go to the Corner Club. She met GONCALVES at the Corner Club around 11:00 PM. GONCALVES, MOGEN and a lot of other people were there. She had a small "run in" with [REDACTED] [REDACTED] at the Corner Club. [REDACTED] was kicked out of the bar around the same time, or not too long before, MOGEN and GONCALVES left the Corner Club. She stayed at the Corner Club until approximately 2:00 AM and arrived home at approximately 2:30 AM. She was up until approximately 3:30 AM, and did not hear anything.

6. She woke up Sunday morning at approximately 7:30 AM. She had been in a different room than her own. She and roommates made breakfast around 8:30 AM. Later when she went to her room, she could see a lot of police cars next door.

7. She spoke with [REDACTED] (the Uber driver), who told her he was pretty sure he had taken MOGEN and GONCALVES home that night. [REDACTED] drove a smaller gray sedan.

8. GONCALVES old room, was the room KERNODLE was living in. GONCALVES recently moved into the room on the 3rd floor after [REDACTED] [REDACTED] said she was not moving back in.

9. GONCALVES did not seem at all worried about a stalker, or any other dangers. She thought GONCALVES would have said something if there was a real stalker. GONCALVES would have been scared if she had a stalker, instead GONCALVES was planning events for them all the time.

10. Her bedroom window looks out onto 1122 King Road's backyard. She can usually hear anything going on in their backyard. Murphy, the dog at 1122 King Road, usually barks a little bit, and she can generally hear it, which she didn't recall happening that night.

11. She had booked tickets with GONCALVES to go to Europe together, approximately 3 weeks prior to the homicides. GONCALVES had recently sold a white Subaru sedan for approximately \$6,300 to a man using Facebook Marketplace. GONCALVES had just purchased the Range Rover the previous day. GONCALVES was making good money, but a Range Rover seemed expensive. GONCALVES was recently offering to buy drinks for friends quite often.

12. GONCALVES had planned to move to Texas and had a temporary male roommate arranged down there.

13. GONCALVES had an ex-boyfriend [REDACTED] [REDACTED] who is [REDACTED] neighbor. GONCALVES and [REDACTED] dated for approximately 6 years. GONCALVES and [REDACTED] dated all summer while GONCALVES was up in Moscow working. GONCALVES and [REDACTED] were not together but were good friends. GONCALVES and [REDACTED] shared a dog, "Murphy" together. MOGEN had a boyfriend [REDACTED] [REDACTED] in Boise, who was friends with a lot of [REDACTED] friends who had graduated.

14. GONCALVES stayed in her old room while she was living in Moscow all summer. GONCALVES only had one roommate during the summer, [REDACTED] [REDACTED] GONCALVES worked for [REDACTED] and ended up getting a full-time offer starting February 2023. She does not think GONCALVES went out much during the summer. [REDACTED] had just graduated and stayed in Moscow for the summer.

15. She did not think [REDACTED] [REDACTED] had anything to do with the incident. [REDACTED] showed a video from a party earlier on game day, which showed what [REDACTED] was wearing, which appeared to be the same as a person from a video from the Grub Truck. [REDACTED] remembers, GONCALVES and MOGEN saying they were going

to John's Alley, and [REDACTED] [REDACTED] was going to go with them.

16. [REDACTED] was not good friends with GONCALVES and MOGEN, but MOGEN is kind of friends with a lot of the people involved with the Greek houses. [REDACTED] is in the same pledge class year as [REDACTED] GONCALVES, and MOGEN, and has been in a lot of their classes.

17. [REDACTED] [REDACTED] showed a screen shot of a group message obtained by [REDACTED] [REDACTED] [REDACTED] [REDACTED]. The author of the message seemed to know a lot of information regarding the homicides.

18. [REDACTED] [REDACTED] had read some creepy comments on YouTube and obtained screen shots of some of them. [REDACTED] [REDACTED] turned over a flash drive with some of the comments.

19. She did not believe there was a party at 1122 King Road on Saturday (game day).

20. People often used the sliding door as the main entrance for the house. She does not think it was usually locked.

21. GONCALVES and MOGEN didn't use drugs. She didn't know KERNODLE well enough to comment on her.

22. The neighbor's dogs behind them also did not bark at anything that night.
