1. On November 17, 2022, at approximately 0952 hours, I, Idaho State Police (ISP) Detective Brady Walker, called [2001] at regarding this case. ISP Detective Matthew Heinle was present during this phone call. In the previously called into the tip line with information, and this report summarizes the facts she provided during the follow-up call.								
2. has known Madison Mogen and Kaylee Goncalves since the senior year of high school, and they have attended the University of Idaho since then. was in a relationship with the latest of Kaylee Goncalves. hung out with Mogen and Goncalves infrequently and they have stayed in touch during their attendance at University of Idaho. Outside of class, she estimated they socialized (such as attending weekend parties together) about once every two weeks although the frequency varied.								
3. On the late evening of Saturday, November 12, was at house, which is a from 1122 King Road. and his friends were watching sports and was getting bored. contacted Goncalves about wanting to hang out, and they made plans to go to the bar. went to 1122 King Road but couldn't remember the door code. She called Goncalves at approximately 2220 hours, got the door code, and went inside. saw Goncalves and in the house. About five minutes after got to the house, Madison Mogen arrived.								
4. Mogen, Goncalves, and got a ride to the Corner Club from a male named last name was not provided, but his phone number was: Uber driver, and she had been getting rides from him since April 2022. Was described as a white male having hair, a voice that was not deep, and was believed to be shorter in stature since he scooted his seat close to the steering wheel. If the corner Club from a male named last name was noted several things about l								
originally met Goncalves and Mogen, and several other women, through driving for . He provided his personal phone cell phone number as contact for rides. Goncalves, and Mogen commonly called for rides. Sometimes, he would not charge them for the rides. Sometimes, it seemed that was not working for when he would give rides, and that he had left his personal life to accommodate the ride. Began carrying "airplane shooters" of alcohol in his vehicle in the console and had offered them to knew that two women, and and seemed his personal life to accommodate the ride.							>

6. Initially thought was a nice guy who helped women get to their preferred locations safely. She did not think behavior was odd until pointed out that he thought so. After considering the circumstances and all she had learned, she agreed with that it was odd for to provide his personal phone number and be so accommodating to all the women, considering he was married with a child.
had recently become a father. This seemed to be common knowledge. On November 12th, after picked them up, asked how it was going being a father. It did not seem as joyful as she expected. He sighed and pointed out that it was a lot more difficult and stressful than anticipated. It made a point to tell them his wife and baby were out of town for the weekend, and he was looking forward to having the house to himself over the weekend and watch football. It did not really talk to him after that and Goncalves or Mogen continued conversation until they got dropped off at the Corner Club.
8. did not remember a time that had made her feel uncomfortable or unsafe in the time she had known him.
9. At the Corner Club, remembered the core group of friends hanging out as herself, Mogen, Goncalves, and some state of the core group of friends hanging out as herself, Mogen, and good and good and good and good and good and kept trying to get her phone number. It did not give it and did not want to interact with him. It was staring at her to the point noted it was uncomfortable. It ried to convince to give him phone number, but she refused. It and her friends essentially worked on keeping and apart since he was making her so uncomfortable. Eventually, was removed from the bar.
9. spoke of what she described as "a weird interaction" among Goncalves, Mogen, and described as a "weird" person who was fairly aggressive and got into a lot of fights. was not a person that she, Goncalves, or Mogen would typically associate with. Goncalves and Moger left the Corner Club with and it was understanding they were going to John's Alley. almost went with them, but his friends convinced him to stay at the Corner Club. did not see them leave so she was not exactly sure what time that was. Mogen would both leave with since he was not their "type" of people.
10. could not remember what time she and left but took a video of drinking a beer. The timestamp of that video was approximately 0100 hours on Sunday, November 13. After that, they left the Corner Club on foot.
11. was a group of friends and classmates. When got home, she went to bed. She woke up on Sunday morning and saw a notification that a video had been sent from either Goncalves or Mogen. The video was of Goncalves and Mogen outside a food truck. described them as "acting goofy" while taking the video and enjoying themselves.
12. was somewhat emotional during the interview. I told that other investigators would possibly be in touch with her.
13. Investigation continues. End of report.
