Narrative

On November 28, 2022, at approximately 3:14 p.m., I took digital photographs of the victim's vehicles located at 1122 King Road, in Moscow, Latah County, Idaho.

All of the vehicles were unlocked except for the red Jeep Sahara Wrangler. Wearing nitrile gloves, I breached the evidence tape seal on the front door of the residence, retrieved the keys to the Jeep which were sitting on the stairs, and unlocked the Jeep. Once complete, I returned the Jeep keys to the residence and resealed the front door with evidence tape marked with my name and the date.

Copies of the photographs were provided to the Federal Bureau of Investigation to be used to determine what, if any, methods could be employed to download data from the vehicles' onboard computer hardware and/or software.

The photographs were subsequently downloaded onto a compact disc (CD) and entered into evidence.
