Summary Narrative

From November 27 to November 28, 2022, Idaho State Police (ISP) Detective Sergeant T. Hopkins and I, ISP Detective D. Brown, collected surveillance video footage from the [REDACTED] sorority house, the [REDACTED] sorority house, and [REDACTED] captured on November 12 and 13, 2022. We delivered the downloaded footage on memory storage devices to ISP Detective J. Schwecke at the Moscow Police Department.

Narrative

1. On November 27, 2022 at approximately 12:45 p.m., Idaho State Police (ISP) Detective Sergeant T. Hopkins and I, ISP Detective D. Brown, met with [REDACTED], at the [REDACTED] sorority house located at [REDACTED] on the University of Idaho campus in Moscow, Idaho. [REDACTED] was the [REDACTED] of the sorority and provided surveillance video footage from the house, captured on November 12 and 13, 2022. Detective Sergeant T. Hopkins downloaded the footage to a memory storage device. We transported it to the Moscow Police Department and delivered it to ISP Detective J. Schwecke.

2. On November 27, 2022 Detective Sergeant T. Hopkins and I met with [REDACTED], at the [REDACTED] sorority house located at [REDACTED] on the University of Idaho campus in Moscow, Idaho. [REDACTED] was the [REDACTED] of the sorority and offered surveillance video footage from the house, captured on November 12 and 13, 2022. I gave [REDACTED] a memory storage device to download the footage.

3. On November 28, 2022 at approximately 6:55 p.m., Detective Sergeant T. Hopkins and I picked up the memory storage device from [REDACTED] at the house. We transported it to the Moscow Police Department the morning of November 29, 2022 and I delivered it to ISP Detective J. Schwecke.

4. On November 28, 2022 at approximately 3:45 p.m., Detective Sergeant T. Hopkins and I met with [REDACTED] at [REDACTED] a business located at [REDACTED] in Moscow, Idaho. [REDACTED] was the [REDACTED] for the business and provided surveillance video footage from the business, captured on November 12 and 13, 2022. [REDACTED] downloaded the footage to a memory storage device. We transported it to the Moscow Police Department and delivered it to ISP Detective J. Schwecke.
